AGENDA ITEM NO. 31: Comments from the public on any other matter(s) not on this agenda.

Kathleen Espinoza on behalf of the League of Women Voters, stated that the Library Board of Control acted outside of its jurisdiction in denying the community an important library program.

Keith Faulk asserted that the five (5) Library Board members should resign or be terminated.

Jared Eubanks explained that he is ashamed that free money is turned away and that the library cannot talk about anything contemporary unless it is set up as a debate.

Jamal Taylor stressed that the Parish needs to be deconsolidated from the City.

Marja Broussard indicated there should be more compassion for African Americans in Lafayette.

Janice Green affirmed that she celebrates black history everyday and stated that nothing is more dangerous than sincere ignorance.

Takuna El Shabazz advised that the best way for people to celebrate black history is to make more relevant black history based on truth.

Tara Fogleman stated that we have more in common than what divides us. She stressed that living in Lafayette Parish under the current administration is exhausting and embarrassing.

Due to time limit constraints as per Resolution No. JR-037-2020, A vote was taken to extend the length of the Parish Council regular meeting of up to 30 minutes, motion by Naquin, seconded by Carlson, and the vote was unanimous.

Motion to extend the length of the Parish Council regular meeting was approved.

Wallace Senegal indicated that the Mayor-President is doing more for the Parish than he is for the City.

Sharon Patterson explained that Louisiana is consistently last in the nation and we should be tired of being last. She indicated that when there is an opportunity to gain more education, it is turned down.

Alicia Roberts stated that educators should be placed on the Library board and direction should be taken from the most successful library systems in the country like the Los Angeles County Library.
